1 Apologies for absence

2 Minutes of Meeting held Tuesday 1st April

The minutes were accepted and signed as a true record during the Parish Council meeting held on Tuesday 15th April 2008.

3 Matters Arising

The Clerk said that the action to amend the Community Hall hire-agreement re the use of the external store cupboard is outstanding. **Action: N. Poulton/J. Allsop**

4 Acoustics for Main Hall

Mr. Poulton said that he had been told unofficially by East Herts Council that the Community Hall Trustees had been successful in their grant application for £1,265 towards the price of installing acoustic panels in the Main Hall. The grant represents 50% of the cost of Prism Displays quotation of £2,080, plus £450 for installation.

The Trustees agreed that as soon as written confirmation is received from East Herts Council, Mr. Poulton shall e-mail Mr. Eddie Turner (Prism Displays) to accept his quotation and requesting that the work is done as soon as possible.

5 New Tennis Courts plus update on land for additional sports facilities

The Parish Council did not receive the Glebe Committee's decision in June re its request to lease additional land for sporting facilities. Mr. Knight has been in contact with the Diocesan Board and hopes that we will receive an answer before our Parish Council meeting on 15th July.

6 Pavilion Exit Doors

Mr. Meischke said that Brian Bunyan will be fitting the new exit doors to the Pavilion in August.

7 External Painting

This work is complete and an excellent job has been done.

8 Blinds in the Pavilion

The plastic fittings on the bottom of the vertical blinds in the Pavilion are suffering from heat damage. Mr. Poulton to investigate obtaining replacement fittings made from a heat-resistant material (e.g. metal).
