The Parish Council met eleven times in the last financial year.

The Parish Council operates three sub-committees. The Recreational and Amenities sub-committee, chaired by Ian Knight, the Budget and Finance Committee chaired by Denis Filer and the Environment sub-committee chaired by Christine Dinnin.

These sub-committees met as and when necessary, discussed issues and made recommendations to the full council.

The Parish Council made the following donations £400 towards the cost of the Parish News, £65 to Royal British Legion.

The Parish Council has awarded two trophies, one to Watton at Stone Primary School for a "Good citizens Award which was won by Damon Pook and the other to the Scout and Guides for "Outstanding Effort" and this was won by Joanna Wood.

Parish Paths Partnership has allowed us to receive grant money for hedge cutting and strimming work especially on the 'Rights of Way' footpaths.

The Village Directory has been updated and distributed to all the residents in Watton at Stone and Whempstead.

The Parish Council is continuing to work with the Countryside Management Service to improve the Lammas as a Conservation Area and two interpretation boards have been erected.

The two bodies are now working together to produce a management plan to enhance "The Old Cottage" site opposite Watton Green.

Two large decayed trees have been removed from this site as they were in danger of falling onto the highway.

The Parish Council would like to congratulate the organisers of the Family Fun Day held on the 10th July.

Councillors have met with Hertfordshire Highways over the provision of improved lighting in Lammas Road, following a petition from residents.

The Parish Council has been able to secure sufficient funds from Hertfordshire County Council, East Herts District Council and from the Parish Council for this scheme to proceed. It is hoped the scheme will be completed by the autumn.

Investigations are under way to see if a salt bin can be installed at the junction of Beane Road and Walkern Road

ROSPA have undertaken a safety inspection of all our play equipment.
